2. NO post-dated cheques will be accepted
3. Prize donation is required the first day of the fair at the absolute latest.
4. No animals are allowed on fair grounds with exception to service animals and the pet show (which will leave promptly after).
5. We require all vendors to attend all 4 days of the fair. This is for fairness to all of those involved, if vendors are to leave this means less potential customers will be drawn into the vendor area.
6. Spots are assigned by the fair board, placement requests will be taken into consideration.
7. For visitor safety **no vehicles** will be allowed in to set up/tear down while gates are open to the public.
8. The Agricultural society reserved the right to remove any vendor acting inappropriately as this is a family fair. This will be done without refund.
9. If you require more electricity than stated above you MUST let us know by June 30th, we will try our best to accommodate, higher charges may apply.
